

I, Sandeep Dar, Practicing Company Secretary, was appointed by the Board of Directors of Swasti Vinayaka Art and Heritage Corporation Limited (CIN: L51900MH1985PLC036536), at their meeting held on July 29, 2020, as a scrutinizer for the purpose of scrutinizing the e-voting as well as e-voting at the Annual General Meeting (AGM) to be carried out as per the provisions of section 108 of the Companies Act, 2013 read with rule 20 of Companies (Management and Administration) Rules, 2014 as amended, on the resolutions proposed as per the notice of 34th Annual General Meeting of the members of Swasti Vinayaka Art and Heritage Corporation Limited held on Monday, the December 28, 2020 at 03.00 P. M. through Video Conferencing/ Other Audio Visual Means.

Accordingly, I submit my report on remote e-voting as well as e-voting at the AGM as under:

1. The E-Voting period remained open from 09.00 A. M. on Friday, December 25, 2020 and closed at 5:00 P. M. on Sunday, December 27, 2020.
2. The Company had also provided remote evoting facility to the shareholders present at the Annual General Meeting through VC/ OAVM and who had not cast their vote earlier.
3. The Shareholders holding shares as on the "cut off " date, i.e. December 21, 2020 were entitled to vote on the 6 (Six) resolutions as mentioned in the Notice of the 34th Annual General Meeting of Swasti Vinayaka Art and Heritage corporation Limited.
4. After the closure of the remote e-voting at the AGM, the report on voting done at the AGM and the vote cast under remote e-voting facility prior to the AGM were unblocked in accordance with the Rule 20 of The Companies (Management and Administration) Rules, 2014 and were counted.
